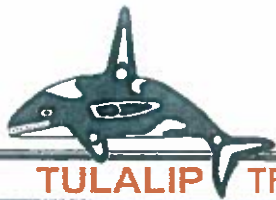




REQUIREMENTS FOR SUBLEASE
